Invitation for Bids

Procurement of two (02) motor cars under operational leasing method.

Sealed bids are called from qualified bidders to obtain two (02) motor cars under operational leasing method by the Chairperson of the Procurement Committee of the Commission to Investigate Allegations of Bribery or Corruption.

Terms & conditions

01. Type of vehicle – (i) Motor cars of maximum engine capacity 1600 CC
(ii) Bids could be submitted for two motor cars or one motor car.
02. Condition of vehicles: Vehicles should be in brand new condition or their running mileage should be below 100,000km at the time of rent.
03. Contract period: Sixty months (60)
04. The qualified supplier should be an institution or a person that maintains services on providing vehicles for rent.
05. Services to be provided: The supplier should bear the repair expenses of accidents. If repair and maintenance activities will take place more than 24 hours or as per the requirement of the institution the supplier should supply a vehicle of similar condition.

Non-refundable deposit should be paid in cash to the shroff at the 03rd floor of the new building of the Commission to Investigate Allegations of Bribery or Corruption at No.36, Malalasekara Mawatha, Colombo 07.

Duly prepared bids could be sent through registered post to the Chairperson, Procurement Committee, Commission to Investigate Allegations of Bribery or Corruption, No.36, Malalasekara Mawatha, Colombo 07 or inserted into the bid box kept at the Accounts Division of this Commission before 2.00p.m. on 12/03/2024. “Procurement of two(02) motor cars under operational leasing method” should be indicated on the top left hand corner of the envelope in which the bids were inserted in. Late bids will be rejected.

Bids will be opened immediately after the acceptance of bids and you or your authorized agent could be attend the bid opening.
