This refers to Commission to Investigate Allegations of Bribery or Corruption [CIABOC] Centralized Electronic System Circular No.01/2026 dated 08.04.2026.

02. In accordance with the above circular, the Head of the Authority is required to appoint a designated officer to manage the dashboard [The list of Designated Authorities is included in the above-mentioned circular.]

03. Heads of designated authorities are required to provide an official email address for the Dashboard.

04. The Commission to Investigate Allegations of Bribery or Corruption will issue a username and password for the email address provided by the designated authority.

05. Details of the Head of the Designated Authority and the Designated Officer nominated for the operation of the Dashboard shall be submitted in accordance with Format 1. It is hereby notified that both the Designated Officer and the Head of the relevant Authority shall be held directly responsible for all activities carried out within the dashboard.

[Any subsequent changes to the particulars provided in Format 1 must be promptly communicated in writing to the Commission's Assets and Liabilities Declaration Division.]



The particulars required under Format 1 shall be duly completed in English by the Designated Officer or another responsible officer and submitted by hand to the Assets and Liabilities Declaration Division of the Commission to Investigations Allegations of Bribery or Corruption located at No. 36, Malalasekara Mawatha, Colombo 7, on working days between 8.30 a.m. and 4.00 p.m.

07. On the same day, the Authorized Officers of the Assets and Liabilities Declaration Division will provide the credentials referred to in paragraph 04 and the list of institutions falling under your purview as a Designated Authority.

08. In order to avoid any inconvenience, you are kindly requested to make a prior appointment by contacting 0767011954 before visiting the Division of Assets and Liabilities Declaration of CIABOC.

09. The presence of the Designated Officer is required for this purpose.
